### 1. General description

The 74HC86-Q100; 74HCT86-Q100 is a quad 2-input EXCLUSIVE-OR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{\rm CC}$ .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.





#### 10.1. Waveforms and test circuit





### Fig. 7. Test circuit for measuring switching times




